<p align="center"><u>Check-in/Rules Meeting</u></p> <p><u>Location:</u> Lincoln Landing Pavilion 740 Travis Drive Lincoln, AL 35896</p> <p><u>Date:</u> Friday, September 23, 2022</p> <p><u>Check-in Times:</u> 5:00p.m. – Check-in Opens 6:00p.m. – Check-in Closes 6:15p.m. – Mandatory rules briefing begins.</p> <p>No teams are allowed to be on the water after the start of check-in, until the tournament begins.</p>	<p align="center"><u>Launch/Weigh-In</u></p> <p><u>Launch Location:</u> Lincoln Landing Pavilion 740 Travis Drive Lincoln, AL 35896</p> <p>Take-off will begin at 7:00 a.m. or first safe light thereafter.</p> <p>Weigh-in begins: 2:00p.m.</p>	<p align="center"><u>Required Items and Safety Equipment</u></p> <p>It is the responsibility of each participant to have ALL required state and federal safety equipment on board as well as, ALL permits licenses, passes or stamps, Etc. required.</p> <p>At time of inspection each morning, be prepared to properly display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch.</p> <p>Inspection will be held during lineup for takeoff. Live wells must be empty.</p> <p>Anglers are required to have a valid AL Fishing License fishing license/ permit, if applicable by law.</p>
<p align="center"><u>Fish Limits</u></p> <p>Large, smallmouth, and spotted Bass 12" inches and over.</p> <p>Anglers are allowed to weigh a limit of five (5) fish per team unless otherwise required by law or tournament officials.</p> <p>Fish presented which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.
