Ed Garrison Arena and Expo Center, 1101 West Queen Street, Pendleton, SC 29670</p> <p>Date: Tuesday, June 18, 2024 – Please do NOT bring boats to registration.</p> <p>Registration Times: 1:00 p.m. – Registration Opens 5:30 p.m. – Registration Closes 6:00 p.m. – Mandatory rules briefing begins</p>	<p align="center"><u>Launch/Weigh -In</u></p> <p>Launch Location: Green Pond Landing 470 Green Pond Road Anderson, SC 29607</p> <p>Daily Take-off will begin at 6:00 a.m. or first safe light thereafter.</p> <p>Weigh-in begins at 1:30 p.m. daily</p>	<p align="center"><u>Off Limits & Practice</u> <u>READ THE RULES CAREFULLY</u></p> <p>Off limits begins Sunday night, June 9th until start of designated practice days which are all day June 16, 17 & up until 12 noon on June 18th.</p> <p>Rules such as lifejacket use, engine stop switch use and sportsmanship also apply on those designated practice days.</p> <p>If both team members choose to practice on June 16, 17 or on June 18, they must do so in the same boat and with a legal Boat Captain. <u>READ THE RULES CAREFULLY</u></p>
<p align="center"><u>Fish Limits</u></p> <p>Largemouth, Smallmouth, Spotted, Redeye, 12" and over</p> <p>Anglers are allowed to weigh a limit of three (3) fish per team unless otherwise required by law or tournament officials.</p> <p>Fish presented which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. An 8-ounce deduction will be made for each fish presented that is determined to be non-releasable.</p>	<p align="center">Site Host Anderson, SC https://visitanderson.com Click Here for a list of area lodging</p> <p align="center"></p>	<p align="center"><u>Required Items and Safety Equipment</u></p> <p>It is the responsibility of each participant to have ALL required state and federal safety equipment on board as well as, ALL permits licenses, passes or stamps, Etc. required. At time of inspection each morning, be prepared to properly display 1 life jacket for each angler; 1 throwable PFD; and, demonstrate functioning kill switch. Inspection will be held during lineup for takeoff. Live wells must be empty. Anglers are required to have a valid South Carolina fishing license/ permit, if applicable by law.</p>

Any live release areas established by the Tournament Director will be off limits. That as well as any additional off limits will be announced at the pre-tournament briefing. Only that water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. All local, state and federal regulations apply.</p>
